The Financial Accounting Standards Board prescribes a recognition threshold and a measurement attribute for financial statement recognition of tax positions taken or expected to be taken on a tax return. Management has evaluated its uncertain tax positions and related income tax contingencies and believes no material uncertain tax positions exist. The Organization's federal and state informational returns for the years ending June 30, 2011 through June 30, 2014 are subject to examination by regulatory agencies; generally for three years after they have been filed.

Management executed a facility lease termination agreement and vacated the premises effective July 31, 2015. This results in removal of the deferred rent liability, \$172,633 and the security deposit, \$17,052 as of June 30, 2015, both netted against rent expense.

In planning for the move out, management donated several fixed asset equipment items to other nonprofit organizations and abandoned the lease hold improvements. The fixed assets disposed have been recognized in the financial statements for the year ending June 30, 2015. The total disposed, related accumulated depreciation, cash in on sale of various equipment items and the resulting net loss of \$ 390,707.

After the year ending June 30, 2015 and prior to the date of this audit report management determined that their membership fees receivable would not be realized, as without a facility management could not fulfill its obligations for such memberships. This resulted in removing the membership fees receivable of \$125,000 and recognizing bad debts.

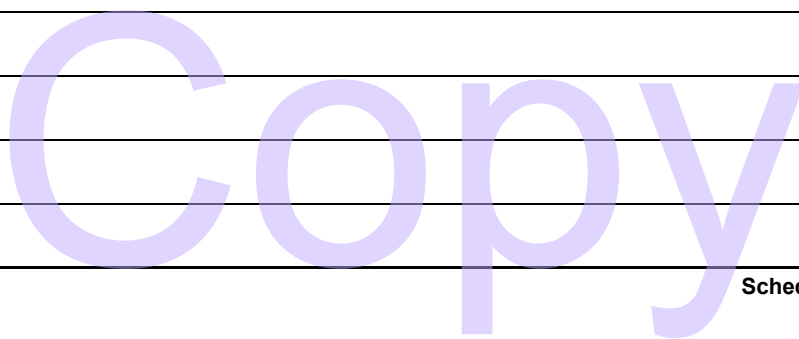
